# Dear Councillor Bailey

This was previously investigated in 2020 (enquiry references ENQ201352386 and ENQ201363394) and as South West Water had attended and found that the water was not from any of their pipes it was thought that it was most likely groundwater from a spring or an unidentified field drain.

The water running down the road is not a safety defect and in view of the category of the road and the scale of works which would be necessary, in an area where there

are no existing drainage systems which could be connected into, a highway drainage scheme is unlikely.

# DEVON COUNTY COUNCIL LOCALITY BUDGETS

As you may be aware Devon County Council, having only just approved the 2022-3 budget, out of the blue and without warning, announced a "temporary suspension" of Councillors' locality budgets. It had already reduced the amount in this financial year from £10,000 to £8000, and to now find that it has been suspended is extremely disappointing not least because it is more important than ever with the ever deeper cuts and the cost of living crisis. This sudden 'suspension' seems a very short sighted and knee jerk approach to me which I am strongly opposed to. There is considerable opposition to the cut from Labour, Lib Dem, Green and Independent members so I do hope that the Conservative controlled council re-thinks this.
